This Memorandum of Agreement (hereinafter "Agreement") is made by and between the Connecticut State Colleges and Universities, Board of Regents for Higher Education (hereinafter "CSCU"), the Congress of Connecticut Community Colleges, SEIU, Local 1973 (hereinafter "Congress"), Federation of Technical College Teachers (hereinafter "AFT"), AFSCME Local 2480 (hereinafter "AFSCME 2480"), Charter Oak State College Professional Bargaining Unit, AFSCME, Local 1214 (Charter Oak BU), Connecticut State University American Association of University Professors, and State University Organization of Administrative Faculty, AFSCME Local 2836 (hereinafter "SUOAF") (collectively "the Bargaining Units").

- 1. CSCU and the Bargaining Units have all negotiated and agreed to Collective Bargaining Agreements for the term July 1, 2021, to June 30, 2025, (AAUP term August 27, 2021 August 26, 2025).
- 2. The state of Connecticut has enacted a law recognizing the holiday of Juneteenth, to be first observed in the state of Connecticut on Monday, June 19, 2023. The parties agree that Juneteenth will be observed as a holiday and members shall be granted the day off with pay.

3. The Juneteenth holiday will be codified as such in the next collective bargaining agreement.
